Q6. Who will this initiative support and how many? (Beneficiaries)

The varying activities of the project will be aimed at older primary age children and young people up to the age of 16 years.

Older primary age children will number about 10 - 20 plus young people numbering 15 - 30 in managed environments plus larger class sized groupings.

This will support young people who have a chaotic family background out of which there is no realistic encouragement to better themselves in education or in life. This means that without the alternative that this initiative offers, the same negative traits of their adult models will be replicated in a new generation.

A local trader recently commented that if he concentrated on selling 'weed' and alcohol he would be a millionaire. This is the adult example many kids are presented with on the estate.

A positive role model that encourages a safe, positive, alternative future is essential for the community.

Q7. For what duration and how frequently will the initiative be operational?

The project will run from Spring 2015 until Summer 2016 initially.

The project will comprise three regular weekly activities supplemented by monthly targeted presentations. This is expected to require 16 hours per week.

Q8. Where will the initiative's beneficiaries reside?

Town/city/village: Kings Heath and surrounding area.

District/Borough: Northampton

Q9. What crime(s) do you foresee the initiative will help to prevent?

The cumulative effect of educative, preventative and alternative safe activity for young people is expected to impact levels of anti-social behaviour and petty crime including vandalism.

The Kings Heath/Spencer area is acknowledged as one of social deprivation. We have continued examples of voluntary and statutory bodies seeking to extricate young people from the consequences and impact of their and parental life choices.

This initiative is an attempt to get education, better choices and opportunity earlier into young lives. 'X' is an immature young man bullied at school. His school was changed but issues continued. Mentoring uncovered the truth which some lies were covering and a dangerous situation at home was

dealt with by other bodies. 'X' is now more settled, truthful and maturing.

Lack of intervention could have led to exclusion, a broken family, a resentful self harming and disillusioned young man with all the accompanying life and community costs. One less person to need a gang to replace family.

Q10. How will your initiative help to increase community safety?

By encouraging a greater sense of personal responsibility for behaviour and also give groups of young people safe and positive environments that will encourage prospects for the future.

Young people tend to hang around, complain there is nothing to do, be influenced by other wrong behaviour and then get into trouble. There are community complaints about this and the Safer Community team are aware. The youth await somebody else to take responsibility for entertaining them.

This initiative will show them that others are interested in them, will provide positive activity and help focus them towards a more hopeful future. This change of atmosphere for, in and around a young person will be amplified when accompanied by similar change in their peers.

For example we have observed a young boy who would verbally lash out, get into fights and encourage similar behaviour in others. Mentoring has helped him deal with the inner anger at his life experience and given him techniques to better handle his response to situations. This benefit then 'seeps' into his circle of friends and their section of community. This is not an isolated example. This initiative will increase this possibility for others.

Q12. How will you actively involve beneficiaries in design, delivery and evaluation of your initiative?

Weekly Youth Drop in.

Design and Delivery: Facilities will be made available and their use and the content of the time will be structured and influenced by the users.

Evaluation: seen in the number of regular attenders and popularity of the Drop In.

Weekly term time Homework Club. Pupils will be the immediate beneficiaries and the benefit to them will be seen in the numbers who voluntary attend. The feedback from secondary beneficiaries, viz: teachers and parents, will also be assessed.

Mentoring by regular appointment. This will be entirely beneficiary led as the issues presented by the young person will be the subject of the mentoring. Evaluation will be evidenced by the individuals response and personal progress.

Drugs Education through school and club presentations. Questionaires will be completed by beneficiaries and assessed.

Q13. Will your initiative be inclusive of (and/or) collaborate with other faith groups and non-faith groups?

Provision of all services will be open to all. Volunteers will be drawn from all faiths and none. We have partnered with the Residents Association and raised funds for a body camera for the local police team.

We sponsor an annual leaders meal that includes all the voluntary and statutory groups on the estate. We have sponsored young people on residential adventure breaks. We have worked with other groups to provide sports and fun days on the estate.

We are currently working with the police etc towards a Community Fun Day in June.

Q14. Will your initiative add any social, economic and environmental value to your community?

It certainly should if young people are given time and opportunity to improve their life chances and take responsibility for their actions and choices.

The young person is more likely not to be involved in anti-social behaviour, to aspire to find a job and get along better with other people.

One young man, lacking family support and education and who has been in the mentoring programme has gained a job and become a junior leader at the youth club.

Damage through vandalism has reduced according to the local safer community team.

Q15. How will your initiative be sustained beyond the OFBCI funding award?

Grant funding remains a possibility, but we plan that the income generation from New 2 You, the local community charity shop and a supporting partner will also increase.

The initiative itself is aimed at personal and community benefit. The only way it could generate income is to charge for the services provided which, as young people are the target clientèle, doesn't seem viable.

Q16. Will this project be part of a wider partnership? (*Please describe the nature/level of partnership and who are your partners?*)

Yes. The income generation from the volunteer based New 2 You community charity shop on the estate has been mentioned above.

The existing youth and community work is regularly liaised with the Kings Heath Residents Association, local schools, church, Borough and County councillors and Police. Introducing eg the Police, can be a sensitive issue for many young people whose upbringing [or lack of] means they see them as the enemy. We have drawn the Police and Fire Brigade into the planning for the Community Fun Day in June. This alongside bouncy castles etc should provide a 'soft' introduction to young people.

Q17. How will monitor and evaluate your performance and what evidence could you use to demonstrate that the project has been successful?

The use of questionnaires, feedback from partners, particularly the school and Police, and the popularity of the project.

Evidence of success would be measured by a combination of:

- 1. Feedback from the school and parents.
- 2. Feedback from the local Safer Community team.
- 3. Attendance records from the various aspects of the project.
- 4. Signs of personal progress in the lives of young people.
- 5. Records of beneficiaries personal comments.
