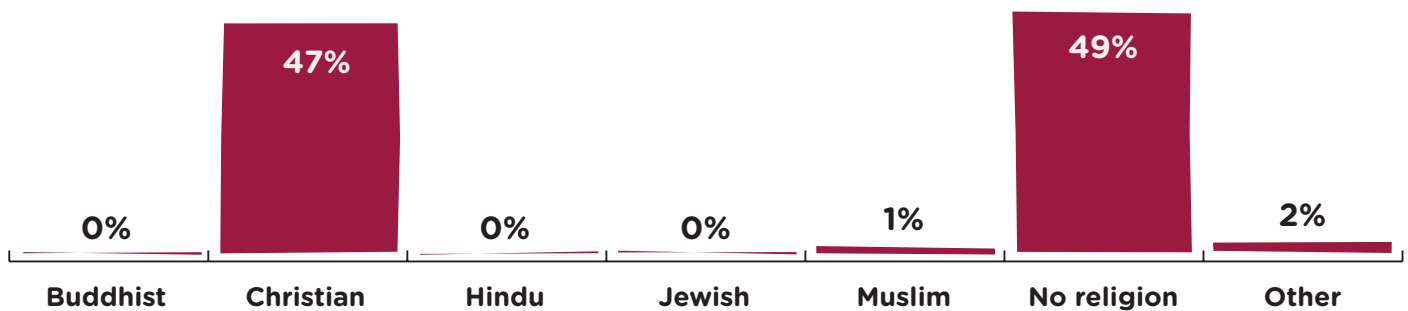
Demographics of service users, of those who stated their demographics.



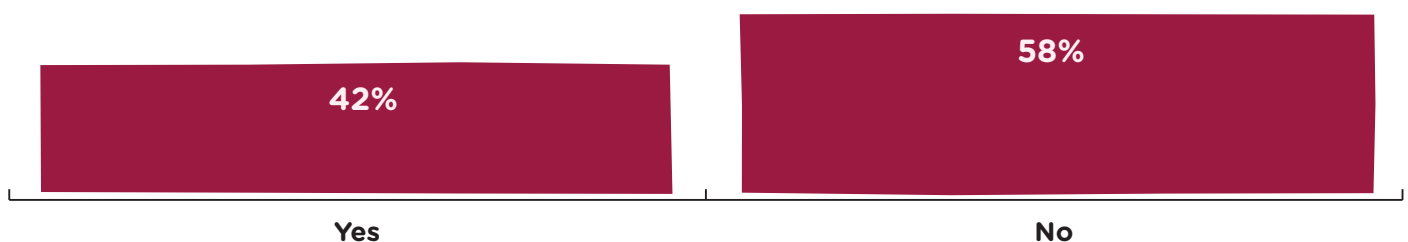

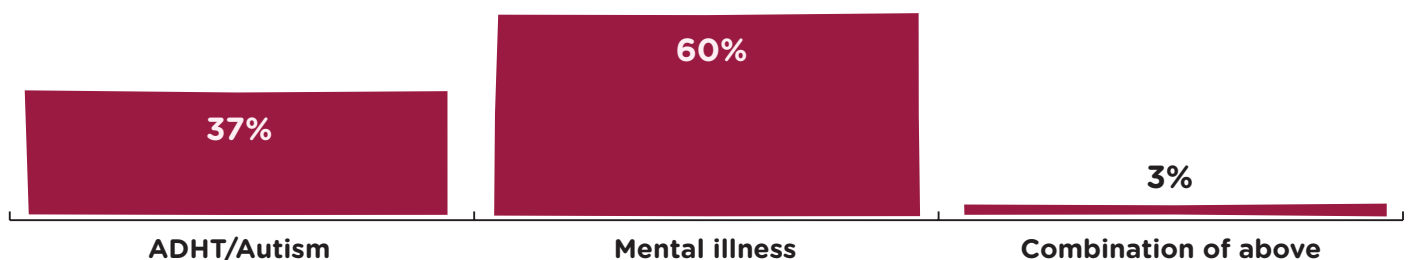
